- All clean fill must be separated into top soil, clay and gravel and must be transported separately.
  - All vegetation including but not limited to grass/lawn, trees and bushes must be removed before the clean fill will be accepted.
  - All contaminants including but not limited to concrete, bricks and building materials must be removed before the clean fill will be accepted.
  - Any clean fill contaminated with asbestos or any other hazardous substance will not be accepted.
  - Clean fill generators may be asked to provide test results showing that the clean fill is not contaminated with any hazardous substances before it will be accepted.
  - If the Clean Fill Disposal Application is approved the clean fill generators will be required to provide Council with five (5) working days notice before they can begin disposal.
  - The disposal fee for clean fill is \$12.00 per tonne. Council may approve for the clean fill to be accepted free of charge depending on whether or not it is required for use onsite.
