


- If the property is owned in a company/business name, an ASIC statement must be provided to prove that the applicant is a director/owner of the company/business.
- Understand that when this application is lodged an adjustment will be made to the property rates on a pro-rata basis.
- Any bin/s supplied by Council always remains the property of the Council and must not be removed from the subject property.
- Changes to a Domestic Waste Service will only be applied once within each financial year.
- Domestic Waste Charge is an annual charge that applies for the full financial year and cannot be cancelled mid-year.
