 Leaves blocking gutters will not, in itself, be considered justification for approval to remove trees.

INFORMATION TO BE SUBMITTED WITH APPLICATION

1. An A3 or A4 sized plan drawn to scale showing the location of the proposed works in relation to any buildings and property boundaries.
2. Arborist reports may be required for applications:
 - a. For significant trees
 - b. If the justification given for the clearing of the vegetation is not supported by the evidence
3. A landscape plan illustrating replacement native species plantings will be required for applications for remnant native vegetation.
4. If work is to be carried out in or over Council's road reserve a s/38 application will be requires. Please contact Council's Operations Department.
