Conditions of Service

- Only authorised vehicles will be allowed to charge to your account. If you wish for vehicles to be added or removed from your account, this must be submitted to Council in writing.
 - All accounts are limited to \$5000 unless approval is given for an increase. Payment terms are thirty (30) days. Accounts outstanding for sixty (60) days will be suspended until the account is brought up to date.
 - Goulburn Mulwaree Council reserves the right to cancel customer accounts or change the conditions of use as required.
 - It is illegal for waste generated in waste levy paying areas to be disposed of at Goulburn Mulwaree Council waste centres. Anyone attempting to dispose of waste from these areas at Goulburn, Marulan or Tarago Waste Management Centres will be reported to the NSW EPA. The waste levy applies in the regulated area of NSW which comprises Wingecarribee, Wollondilly and the Blue Mountains local government areas, the Sydney metropolitan area, the Illawarra and Hunter regions and the central and north coast local government areas to the Queensland border.
 - If applicant is unable to provide two credit references no credit account will be issued.
